Most people would agree that their lives have been positively affected by the Internet and e-mail. The Internet allows us to access large amounts of information on nearly any topic quickly and cheaply. But, in this computer age, the problem that worries many people is their privacy.

The computer age has brought about a new debate over privacy rights. The computer systems have made it easy for companies and other agencies to collect, store, and process data. This results in three dangerous effects. First, companies can collect far more personal information than ever before. Second, they can exchange the data with other companies quickly and easily. Finally, they can use the information in ways that individuals do not know about and cannot control.

To put an end to this problem, the following rules and guidelines have been extended to cover computerized information. First, individuals should know how any company is using their personal files. Second, rules for sharing personal data should be set and then made public. Third, everyone should have the right to inspect, correct, and challenge information in their personal files.

Although these guidelines are a good beginning, finding the correct balance between the rights of companies to collect and use personal data and individual rights is still a big problem that worries many people.
